System Requirements

These specifications refer to the minimum specifications across our range of software applications.

Computer (desktop or laptop)

Minimum PC and system requirements are:

- Intel Core i3 processor (2.0 GHz processor) or equivalent
- 4GB RAM
- 1.5GB free hard disk space
- Mouse
- Monitor: 1024x768 resolution – min 256 colours (recommended 1280x1024) Recommended screen font size 96 DPI (100%).

The following operating systems (with latest updates applied) are supported:

- Microsoft Windows 7 SP1 Home Premium or above (32 and 64 bit)

- Microsoft Windows 10 (32 and 64 bit)
- Microsoft Windows Server 2008 and above (FastTest network installation)

Prerequisites

- An NTFS file system must be used (not FAT32)
- Our software cannot be installed to a compressed drive
- Antivirus and firewall security software should be disabled prior to the installation
- The installation process is designed to run locally, not over a network

Desktop installation

To install from a download:

- Ensure that you are a local machine administrator.
- Close all open applications, including virus checkers, if running, before starting the installation.
- Download the installer using the link provided. Save the file to your PC.
- Double click on the downloaded file to extract the installation files.
- Setup should start automatically.
- Setup will run. Follow on-screen instructions.

To install from a DVD:

- Ensure that you are a local machine administrator.
- Close all open applications, including virus checkers, if running, before starting the installation.
- Insert the Trimble Software DVD in your disk drive.
- Setup should start automatically. Setup will run from the DVD. Follow on-screen instructions.

Concurrent Licence Users

Installation instructions can be found in the 'Installation Guides' folder on the installation DVD.

A new licensing key may be required for your server.

Activating your software

Our software is sold as a single user, single installation licence unless otherwise specified in your licence agreement. The software may be installed and activated on a single computer. Multi- user licence agreements will allow the software to be installed and activated on a specified number of computers.

The software is protected and requires activation before unrestricted use. Before activation there will be full functionality but the message "DEMONSTRATION ONLY" will be printed on all documents.

You will receive reminders to activate the software. However, after 30 days the software must be activated.

How do I activate my software?

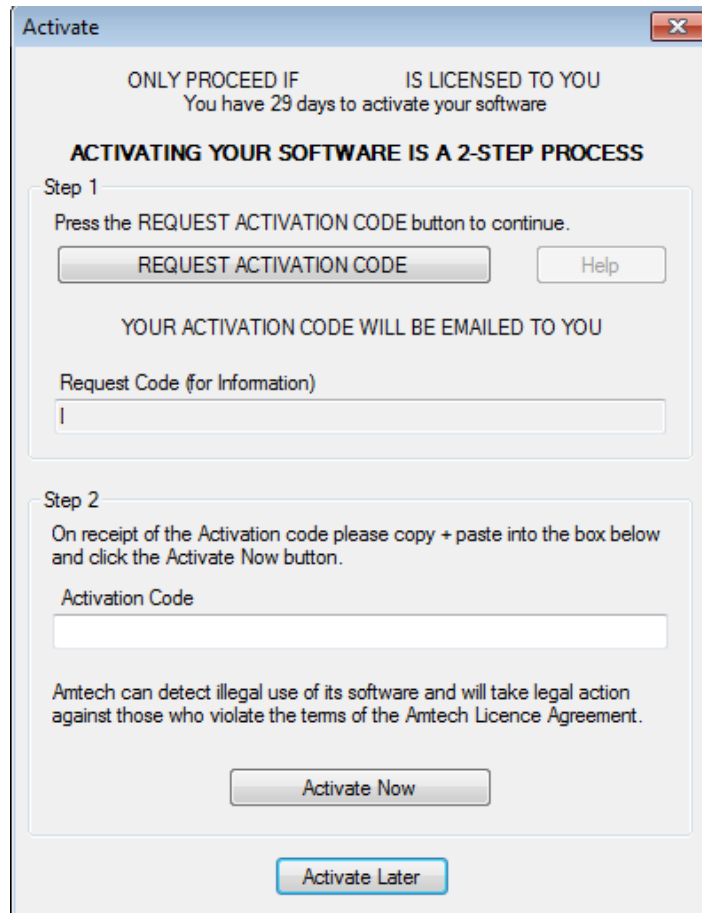
Activating your new software is a two-step process

Step 1 - Send your 'Request Code'

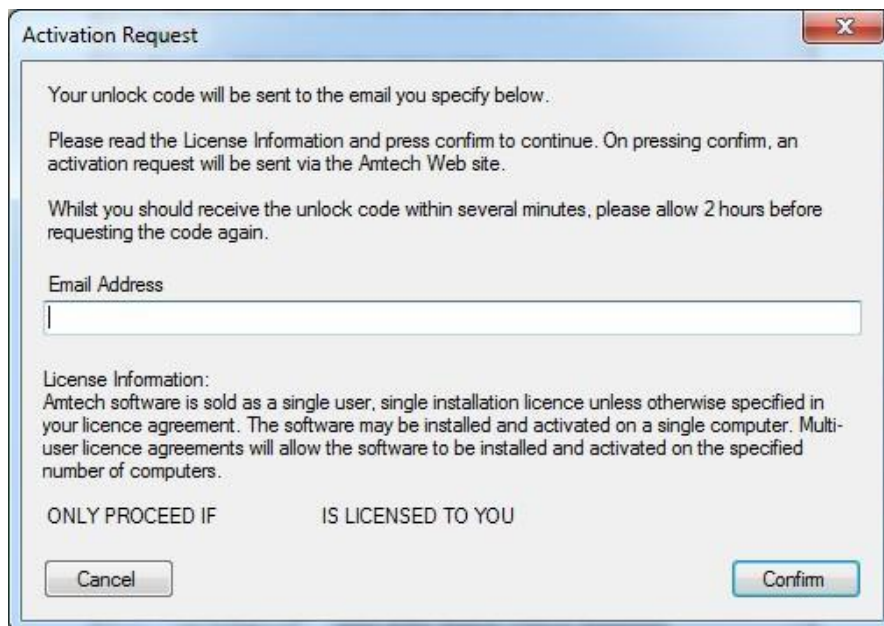
The preferred method of activation is to use the 'REQUEST ACTIVATION CODE' button which sends your 'Request Code' to us electronically. An email auto-responder will check to ensure that your company is the registered purchaser of the software and that there is a user licence available. The auto-responder operates 24 hours a day seven days per week, giving prompt response any time of day.

The Activate dialog box may appear at start-up and various other times indicating how many days you have left.

If the dialog box doesn't appear automatically then it can be accessed by going to the 'Support' menu and selecting 'Activate software'



Click on the 'REQUEST ACTIVATION CODE' button.



On pressing the 'Confirm' button an activation request will be sent via our website. The email response will be sent to the address entered on the Activation Request dialog.

Users who are unable to activate electronically may call the Activation Hotline on 01908 608833 (Monday to Friday 9am – 5pm). A support representative will undertake the security checks manually and then, if appropriate, authorise and issue an unlock code.

Please note: that manual activation process may take several minutes. We strongly suggest that you use the email method if possible as the process of dictating and recording a long code by phone is open to transcription errors.

Telephone calls are recorded to help prevent fraud.

Step 2 - Receive your 'Activation Code' and activate your software

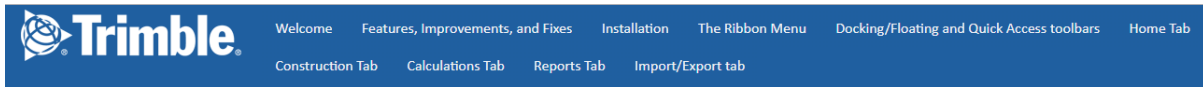
Check your email inbox. If you have not received your activation code by email after a few minutes then check your email system's junk/spam inbox in case the message has been re-directed to there. When you receive your 'Activation code' you must enter this into the lower box. Use copy and paste functions if possible to eliminate transcription errors.

If you have received your activation code by phone enter it into the lower box. Be sure to type it accurately. The majority of the support problems relating to activation are due to incorrectly recorded or mistyped activation codes.

Then click on the 'Activate Now' button to complete the process.

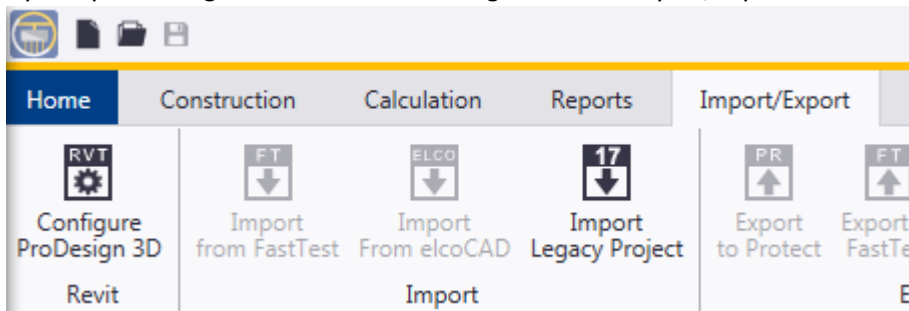
Trimble ProDesign 2018

With the 2018 release, ProDesign has been updated to reflect the changes made to BS7671:2018 IET Wiring Regulations Eighteenth Edition which affect the ProDesign calculations.

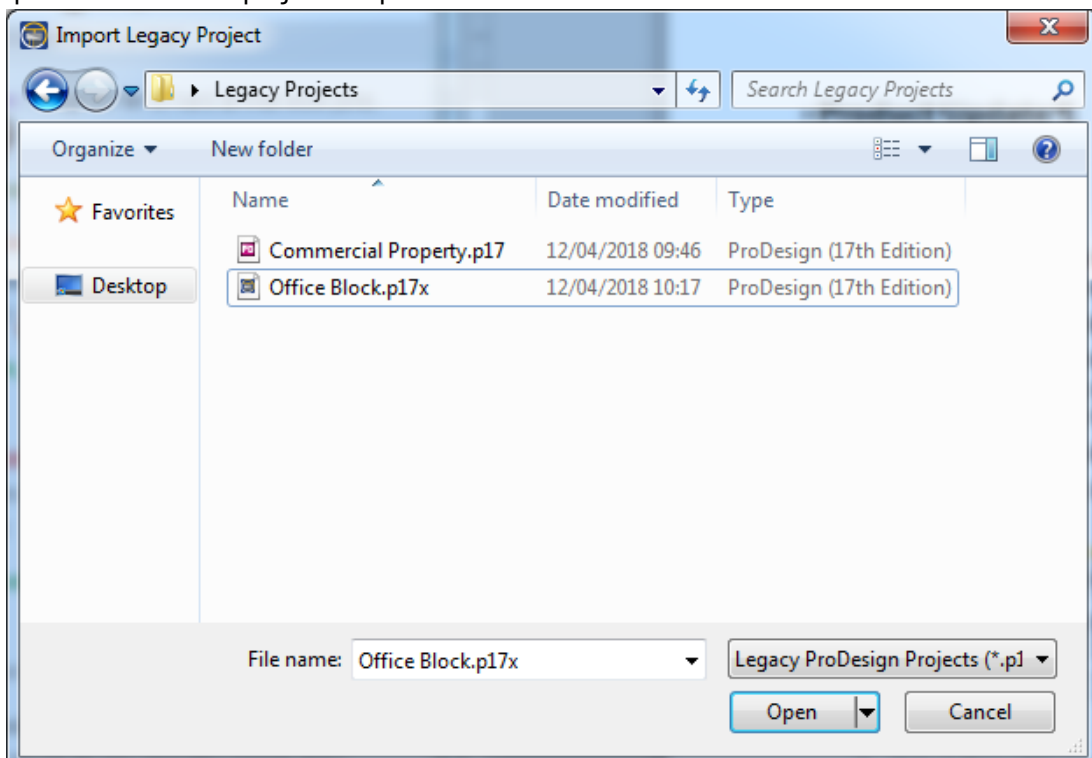
With the new regulation change, comes a new ProDesign file extension, .p18x. All supported customers benefit from being able to Import Legacy Projects (files with .p17 or .p17x file extensions) allowing them to be updated to 18th Edition standards.

To **import a legacy project** follow these simple steps:

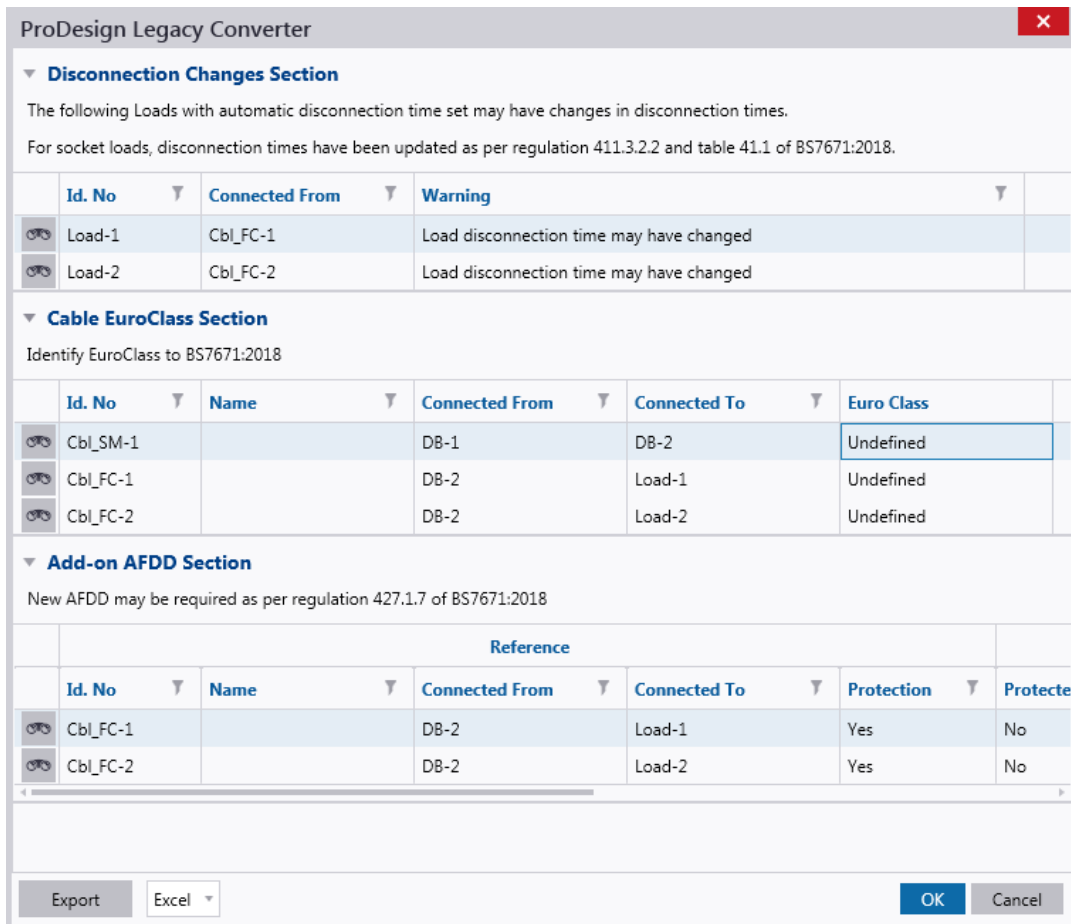
1. Open up ProDesign 18th Edition and Navigate to the Import/Export Tab.



2. Selecting **Import Legacy Project** opens the following dialog box showing only .p17 and .p17x files. Select a project to open.



3. Once selected, the process will begin converting the project to a .p18x file for the 18th Edition. Components that are affected by the 18th Edition regulations are identified in the ProDesign Legacy Converter window:



Certain items can be rectified within the dialog, other items will require to be modified via the ProDesign schematic.

The items that are affected can be exported as an Excel, CSV or PDF file for reference by pressing the Export button, and selecting the file type required from the drop down.

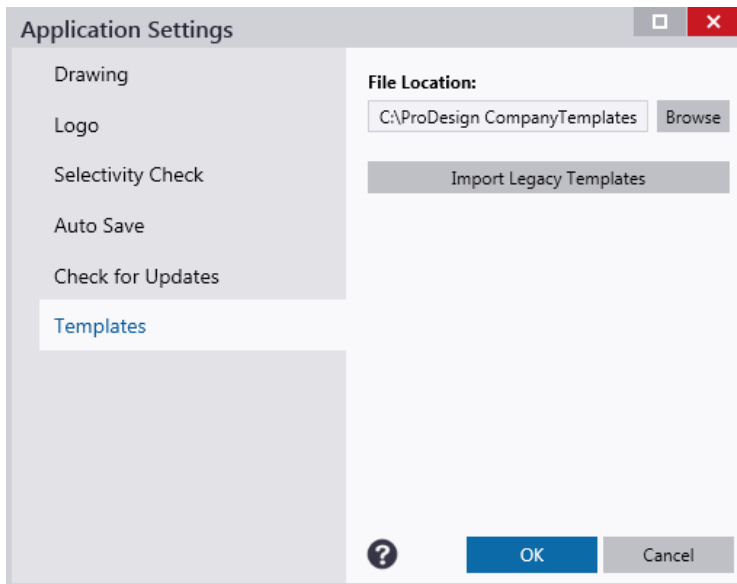
Press **OK** to continue opening the project in ProDesign 2018, or **Cancel** to stop the process.

NB – the project will have to be saved after the conversion to reopen it as an 18th Edition project.

Legacy templates can also be converted for use with ProDesign 2018.

To do this, follow these simple steps:

1. Navigate to the **Application Settings** on the **Home** menu.
2. Navigate to the **Templates** tab, select **Import Legacy Templates** and select the folder containing **.p17t** files for import and select **OK**.



3. If templates are found and imported, a prompt will be shown providing information showing how many templates were found, and how many were imported to the specified file location.

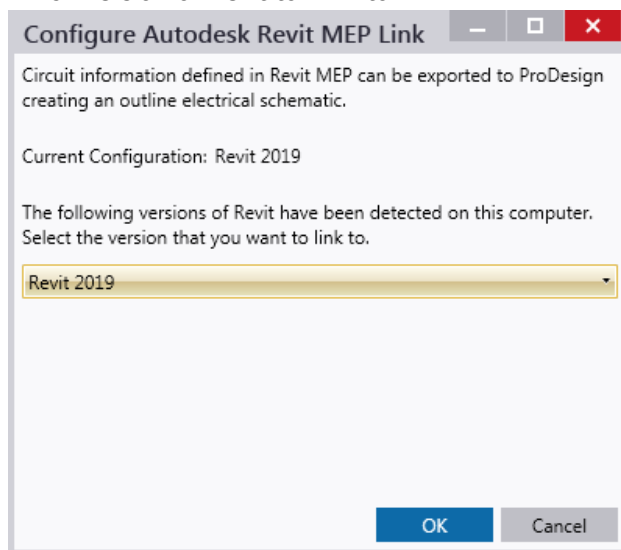

Trimble ProDesign 3D

Trimble ProDesign 3D is a new product that came out in November 2016 offered by Trimble, using the same calculation engine as ProDesign but within the Autodesk Revit 2016, 2017, 2018 and 2019 3D Environments. ProDesign 3D allows the user to have the great features of ProDesign within the Revit environment. This includes data, error dialogs, reporting functionality and protective devices behind ProDesign all still calculating in accordance with BS7671.

Similar to ProDesign, ProDesign 3D customers will need to convert their projects to be calculated in accordance with BS7671:2018. During the installation of ProDesign 3D, customers will be prompted to configure the ProDesign 3D 2018 Revit link. Customers can choose to do this at later date following step 1a or 1b below.

1. Reconfigure the ProDesign3D to Revit link by one of two methods:
 - a. From within the ProDesign software, navigate to **Configure ProDesign 3D** on the Import/Export tab. The following dialog box will appear asking to select which version of Revit to 'link' to.

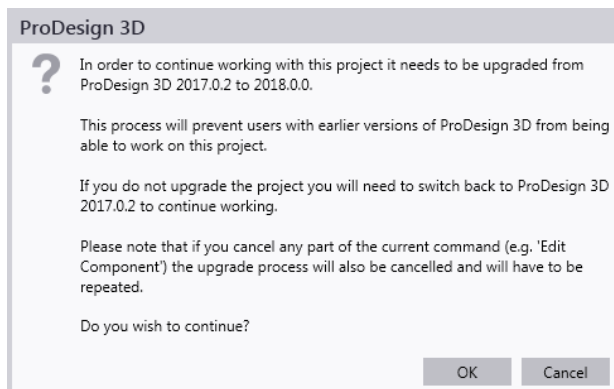


- b. The alternative method is to navigate to the ProDesign 3D installation directory (default directory is C:\Trimble2018\ProDesign 3D) and opening the **ConfigureRevitLink.exe** file. Doing this will open the same dialog as a. above.

To upgrade the project to the 18th Edition regulations please follow the steps below.

2. Open up the Revit project and navigate to the ProDesign 3D tab.
3. Select a button on the ProDesign 3D ribbon (except 'About' or 'Help') to begin the conversion process.

A prompt, similar to the following will appear:



If selecting **OK**, ProDesign 3D will go through the process of upgrading the project to 18th edition. Selecting **Cancel** will stop the process of upgrading the project.

Note: Customers can swap between the different versions of ProDesign 3D (notably between 17th and 18th Edition) if required, by following steps 1a or 1b above for Configuring ProDesign 3D to Revit.

- Once the process is complete, components that are affected by the 18th Edition regulations are identified in the ProDesign Legacy Converter window:

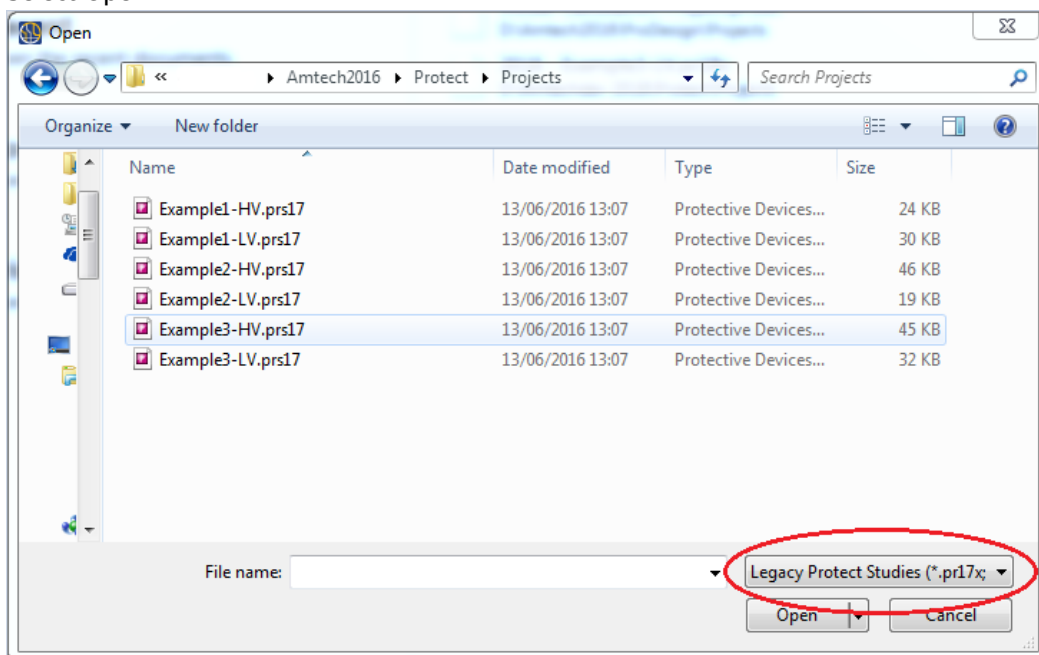

Protect

Protect is so easy to use, you don't need to be a protection expert to use it. The software contains a database with data on thousands of protective devices. This is data direct from, and approved by, leading manufacturers so you can be confident in its accuracy. This is particularly important as so many adjustable breakers are being used these days – it is essential to get these set correctly at the outset. Nobody wants to revisit jobs to sort out nuisance tripping that could so easily have been avoided at the design stage.

Whilst there are no calculations being performed, to keep in line with other projects, the Protect file extension has been changed to .pr18x. Projects saved with .prs17 and .pr17x file extensions can still be opened by following these simple steps:

1. Open up Protect and navigate to Open from the Home tab.
2. Select **Open from local computer**.
3. From the dialog, change the file type to .prs17, .pr17x from the drop down.
4. Select Open.



5. Save the project.

Single Cable

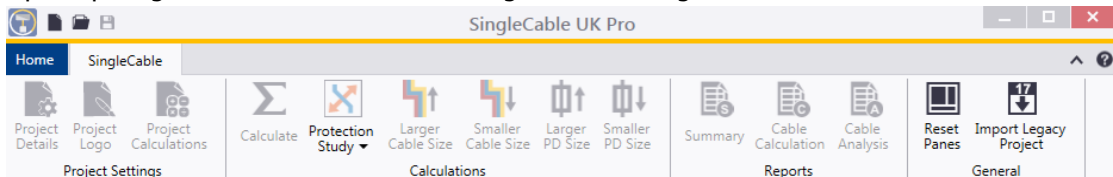
SingleCable is a cable calculation software that is extremely simple to use and provides results in seconds, whether the cable is a sub-main feeder or final circuit. Once calculated, the program also enables you to look at the results for the next cable size larger or smaller, and the same facility is available for the protective device. This is most useful for looking at 'what if' situations, a luxury not available when doing calculations manually.

As with ProDesign, the 2018 SingleCable release has been updated to reflect the changes made to BS7671:2018 IET Wiring Regulations Eighteenth Edition which affect the SingleCable calculations.

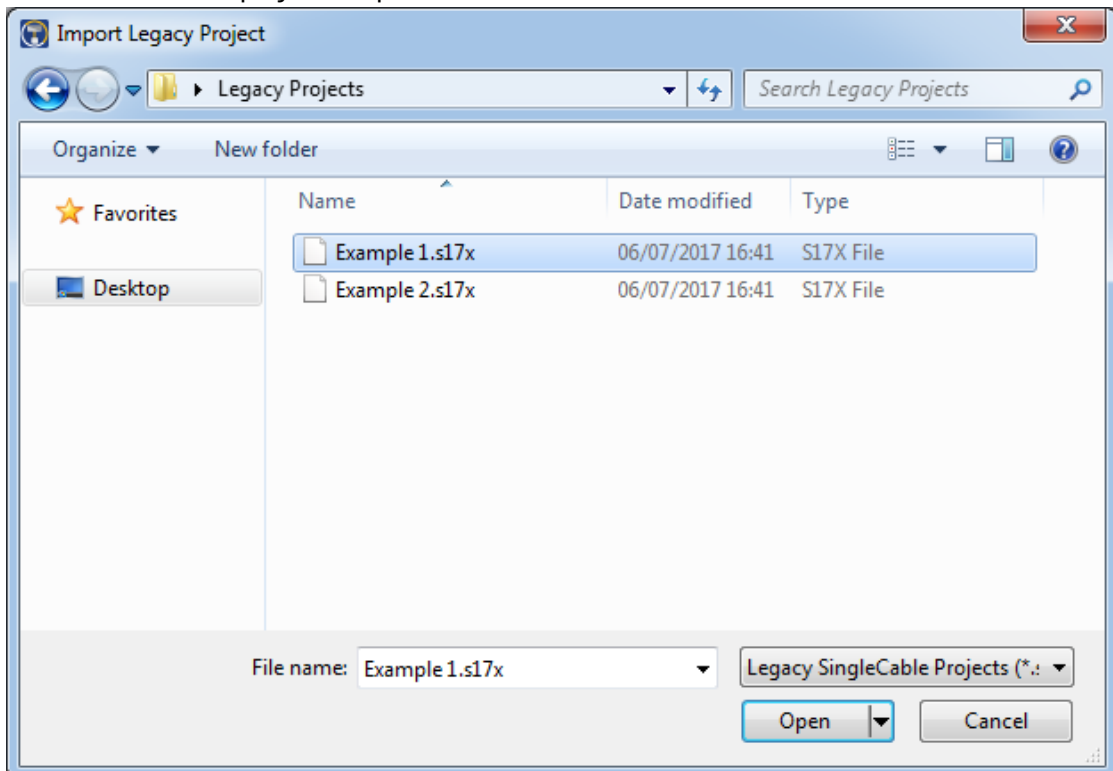
With the new regulation change, comes a new SingleCable file extension, .s18x. All supported customers benefit from being able to Import Legacy Projects (files with .s17 or .s17x file extensions) allowing them to be updated to 18th Edition standards.

To **import a legacy project** follow these simple steps:
