



ACCOUNTS - DELETING A TRANSACTION / BATCH


The 'Post Corrections' routine has been enhanced so that when a transaction or batch is deleted the user is required to enter a reason for the deletion.



The reason is shown as a hint when viewing an account and displaying deleted transactions by pointing at the relevant line and waiting.






